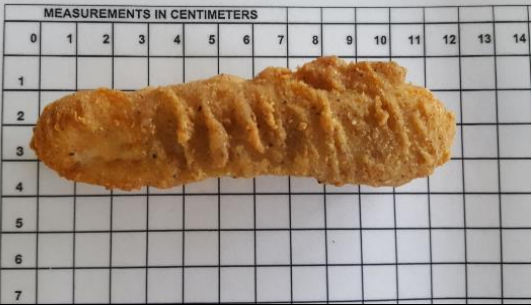

Deep Fry:	Heat oil to 180°C, cook for approx. 4 mins.
Air Fry (1800W):	Cook at 200°C for approx. 6 mins.
